

# L. Starla's Fan Art Contest Terms & Conditions

The promoter is Laelia Starla, Independent Author, with registered business in Australia.

There is no entry fee and no purchase necessary to enter the Promoter's competition.

This contest is open internationally to all visual artists whether professional or not.

Laelia Starla's family members will not be eligible for prizes.

Closing date for each contest is listed on the entry form. After this date no further entries will be permitted.

Only image file types may be submitted. Maximum file size for artwork submission is 5MB. Preferred aspect ratio is 1,600 pixels (w) x 2,560 pixels (h).

No pornographic content is permitted. This includes any display of sexual organs or activity. Only family friendly images will be shortlisted.

The shortlist will be chosen and verified by Promoter. Shortlisted contestants will receive an eBook copy of the relevant box set upon release.

All contestants permit the promoter to freely share submitted artwork on social media networks and on the promoter's website. Artists are encouraged to copyright their artwork and protect it with a watermark. Submissions will not be used by the promoter for any other purpose not agreed to herein.

One winner will be chosen from the shortlist by public voting.

The winner agrees to the use of his/her artwork for the cover of the box set both in digital and print form. To be eligible for the main prize, a high resolution, watermark free version of the artwork must be submitted through email correspondence.

Route to entry for the competition and details of how to enter are provided on the entry form. Each individual is limited to one entry per contest.

No responsibility can be accepted for entries or prizes not received for whatever reason.

The promoter will notify the winners by email to arrange delivery of prizes.

Restrictions apply to shipping physical prizes to certain locations. These are imposed by government bodies and the promoter will not be held liable for such limitations.
